But reacting to the situation, the National Association of Government Registered Freight Forwarders (NAGAFF) said that while it does not encourage importa-tion of substandard goods, the penalty was high-handed and an over-kill on importers.

Founder of NAGAFF, Dr. Boniface Aniebonam, while advising importers against the importation of substandard

importation of substandard goods, however, said that the penalty introduced by SON was counter-productive. Aniebonam who told THISDAY that the penalty used to be N200,000 described the NL5 million as penalty and deposit respectively as outrageous, adding that instead of achieving result, it will force importers to look for alternatives.

Aniebonam called on the staff of SON to take advantage of the reform measure at the ports to do the right thing. He said that as far as he was concerned, the new boss of SON needs to change some corrupt officers in the ports if he wants to succeed.

The NAGAFF founder however pleaded the support of the association to the new chief executive of SON, adding that his members have been directed to advise their importers to avoid bringing into the country substandard
